This product is tank mix compatible with most fertilizers and pesticides. However, due to variability in water sources and pesticide formulations a compatibility test is recommended.

Golf Course Greens, Tees, and Fairways Sports Turf

Apply 3.0 to 9.0 fl oz per 1000 sq ft in 0.5 to 2.0 gal spray solution per 1000 sq ft.

Repeat application every 3 to 6 weeks during the growing season.

May be tank mixed with other soil applied products. Dries safely on the leaf surface, but for best results water into soil profile as soon as possible.

Residential and Commercial Lawns

Apply 1.0 to 2.0 gal per acre in 25 to 88 gal per acre of spray solution.

Repeat application every 6 to 8 weeks.

Do not store in temperatures below 40°F.
