DIRECTIONS FOR USE

ALWAYS FOLLOW THE DIRECTIONS ON THE LABEL OF ANY PEST CONTROL PRODUCT!

Do not increase the amount of SME beyond that allowed on the label. If the label allows for the use of an MSO product, but does not recommend a rate, add 3.0 – 4.0 pints per 100 gallons of water. More may be required on species with heavier cuticles, or under dry or dusty conditions or for more mature weeds.

PRECAUTIONARY STATEMENTS

Harmful if absorbed through skin, do not get in eyes or on clothing. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco or using the toilet. Remove and wash contaminated clothing before reuse.

Personal Protective Equipment: Wear chemical resistant gloves, long-sleeved shirt, long pants, socks and shoes.

FIRST AID

Call a poison control center or doctor immediately for treatment advice. Have the product container with you when calling a poison control center or doctor, or going for treatment. **If Swallowed:** Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person. **If on Skin or Clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15 to 20 minutes. **If Inhaled:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferable mouth to mouth if possible. **If in Eyes:** Hold eye open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses if present, after the first 5 minutes, and then continue to rinse eye. **Note to Physician:** Probable mucosal damage may contraindicate the use of gastric lavage.

STORAGE AND DISPOSAL

STORAGE: Store in a cool, dry place. Store in original container only. Do not add anything to the container. Keep container tightly sealed when not in use. Do not store near fire, flame or other potential sources of

ignition. **DISPOSAL:** Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best method of disposing containers if allowed by law. The Agriculture Recycling Container Counsel (ACRC) operates the national recycling center program. Decontaminated containers and materials must be disposed of in a manner allowed by local, state and federal laws and regulations. **CLEAN UP:** Rinse each spray tank out after each use and flush thoroughly. with water for 15-20 minutes. Remove contact lenses if present, after the first 5 minutes, then continue to rinse eyes.
