Read and follow the precautions and directions for use on this label and the pesticide it is being applied with.

MIXING

Fill spray tank 1/2 full, add the desired amount of herbicide and continue filling. Add the **LESCO MSO** last. After filling, continue agitation. Always follow pesticide label directions, acceptable practices and advice from your crop consultant.

RECOMMENDED RATES

Apply at 1 - 4 pints of **LESCO MSO** per 100 gallons of spray solution.
